## **Code Escape: Terms and Conditions of Sale**

By my purchase of a ticket from **Code Escape** ("The Company") for the activity; Real Live Escape Game ("Activity"), to be conducted on **3F UnHyun Building**, **36 Bongeunsa-ro-4-gil**, **Gangnam-gu**, **Seoul**, **135-931** ("the Premises"), I read and understand all terms and conditions described as below, and I consent to:

- 1. The Activity entails;
  - Being locked up in an enclosed room for a duration of up to and around one (1) hour alone or with my accompanying person(s).
  - Being blindfolded, having my ears covered and/or having my movement restricted with handcuffs or rope.
- 2. I understand that the Activity can be physically and mentally strenuous and requires a certain degree of physical and mental wellbeing, ability, maturity, temperament and other problem solving skills.
- 3. I understand that I will be locked in an enclosed room as soon as I enter into the room. I can escape the room with the act of searching for items/clues, exploring such enclosed rooms and/or breaking any hidden codes.
- 4. I understand that I will be locked in an enclosed small room for a duration of up to and around one (1) hour along or with my accompanying person(s). Therefore, I understand that all participants must follow the instructions below.
  - To prevent fire, all flammable materials (including, but not limited to, lighter and/or match) are not allowed in rooms. All flammable materials should be removed and kept in a separate cabinet prior to participation of the Activity or entering the room.
  - The participant(s) with a fear of small spaces (claustrophobia or any similar fear) who is not able to stay in a small room for a duration of up to and around one (1) hour should disclose this to the Company employee(s) prior to participation of the Activity. The Company may not allow or terminate my participation for safety reasons. In case of participation without prior notice / disclosure, the Company shall not be liable for any personal injury or injuries, loss of life or any other damages caused by its non-disclosure.
  - For any emergency cases during the participation, the key to exit the room and the interphone are installed in each room. Therefore, I am aware that I can use the key to escape the room on my own by breaking the security key box or contact the Company employees for help in case of any emergency situation.
- 5. I understand that pregnant women and elders may not be allowed to participate in the Activity for certain theme room(s) due to its violent and sexually suggestive contents. However, the child, infant or minor who have the written consent obtained from legally authorized representative or who accompany with adults are allowed to participate in the Activity with the condition that legally authorized representatives or the accompanying adults undertake to fully explain the Activity's nature, precautionary measures and its terms and provisions contained herein to any such child, infant or minor.
- 6. I understand and agree that anything related to the Activity (including, but not limited to, room interior design, furniture, any items located within rooms, clues or information to escape rooms etc) keeps confidential. Therefore, I understand that I have civil and penal responsibility for any loss and expense incurred by the Company from any serious disclosure of any information which is the result of my negligence or intentional torts (including the result from my children, infant or minor under my responsibility). In addition, I agree to keep all filming/recording equipment/mobile devices (including, but not limited to, mobile phones, camera, paper and pens) in a separate cabinet prior to participation of the Activity.
- 7. The Company shall not be liable for any personal injury or injuries, loss of life, damage to or loss of personal property sustained by me or any child, infant or minor under my responsibility during the participation of the

Activity and/or whilst on the Company Premises. Also, I shall indemnify the Company for all damage, loss and expense incurred by the Company in order to repair, rectify, and/or replace any furniture, fixture, furnishing, and/or object on or forming part of the Premises caused by or contributed to by me or any children, infants, or minors under my responsibility which is the result of my negligence or intentional torts.
